- Informational Warning Notices to all City Facilities

# USE OF SAFE AND SANE FIREWORKS

---

- Must have Fire Marshall seal to be allowed
- Sales allowed starting 6/28 from noon to 9pm, on the 4<sup>th</sup> from noon until 11pm
  - Use permitted during same timeframes
- Use on private property only, at least 10 feet away from any structures
- Not permitted in parks, public parking lots, schools or open space areas
- Misuse of Safe and Sane Fireworks is dangerous and illegal



# ILLEGAL FIREWORKS ENFORCEMENT

---

- All PD Staff will be working the 4<sup>th</sup> of July
- Marked units, unmarked units, bicycles, surveillance teams, etc.
- \$1,000 administrative citation for use/possession of illegal fireworks
  - Social host citations
- Only report violations with specific suspect information
  - Majority of citations do not result from resident reports
